Ministry of Education, Government of India vide their letter no. F.No.4-3/2002-UT-2 Sch.3 dated 25th May, 2021 has communicated the approval of the Competent Authority for transfer of the following 06 Senior Secondary Schools from the Central Tibetan Schools Administration (CTSA) to the Sambhota Tibetan School Society (STSS), Central Tibetan Administration (CTA), Dharamsala in the fourth phase, in pursuance of the decision of the Union Cabinet of January 10, 2013 :

CTSA is processing the matter of transfer of these schools immediately. The Indian staff members have been asked to submit their options to be transferred on permanent absorption basis to KVS/NVS/CBSE/DM schools of NCERT. On receipt of the same, their names will be send to the respective organizations for permanent absorption. On receipt of the consent of these organizations, these employees will be transferred to the concerned organization on the actual transfer of these 06 schools to STSS.

You are therefore, requested to keep a suitable plan ready to take over these schools with the consent of this administration.
